The Will Kankakee Regional Development Authority (WKRDA) was created by action of the Illinois General Assembly and the Governor. WKRDA is a general development agency for the counties of Will and Kankakee. The Authority's financial and supportive powers enable it, with the written approval of the Governor of the State of Illinois, to issue Taxable, Tax-Exempt Bonds and Moral Obligation Bonds for the purpose of developing, constructing, acquiring or improving properties or facilities for business entities locating in or expanding within the territorial jurisdiction of the Authority. The Will Kankakee Regional Development Authority was created by an act of the legislature and signed into law by Public Act 86-1481 on January 14, 1991. The Authority is a ten member body of which three members each are appointed by the County Chairmen of Will and Kankakee and the Governor, with consent of the Senate. The Director of the Department of Commerce and Community Affairs serves as an ex-officio member.
